

**24th Annual NASTR Endurance Rides**  
**Hosted by the Nevada All-State Trail Riders, Inc.**  
**AERC Sanctioned / AHA Region #3 Local Rides**  
**30 / 50 / 75 miles - June 28, 2008**

**LOCATION:** Dayton Valley Fairgrounds in Dayton, Nevada located approximately 11 miles east of Carson City on Highway 50 East. Turn RIGHT at the stop light in Dayton onto Dayton Valley Rd. Heading West on Hwy 50 from Silver Springs turn LEFT. Immediately after crossing the Carson River bridge turn RIGHT onto Ricci Road (you will see the sign to Rodeo Grounds). Follow ½ mile, turn LEFT into the Dayton Rodeo Grounds. Horse water will be available.

**TRAIL:** The rides will run in a figure eight loop, with an out vet check. Crews will have limited access, crew bags can be sent out to the check. Hay, water and lunch will be provided by ride management. The trail is of moderate difficulty in the Pine Nut Mountain Range. There are several rocky creek crossings in Eldorado Canyon which will be ridden at the start and finish of all the rides. The trail has a variety of sandy and rocky terrain in a wooded juniper and pine nut forest, with scenic views and rock formations. Elevation ranges from 4,500 to 6,500.

**75 MILE AERC / AHA #08079086 LOCAL RIDE:** The 75 mile ride will consist of the 50 mile figure eight trail, plus a 25 mile loop trail from the out vet check. The 75 mile ride must be completed in order to be in contention for the NASTR Triple Crown, which includes the Nevada Derby 50, NASTR 75, and the Virginia City 100.

**50 MILE AERC / AHA #08079085 LOCAL RIDE:** The 50 mile ride will run in a figure eight loop, with 2 out vet checks.

**30 MILE AERC LD RIDE:** The 30 mile trail is one loop with the out vet check half way. This limited distance (LD) ride is being held to promote trail use and trail awareness among local horseback riders. It is intended primarily as a training ride for new riders and young or inexperienced horses. There is no emphasis on winning. Every successful finisher will receive a completion award. All proceeds will go towards trail preservation.

**VETERINARIANS:** Head Vet; Susan McCartney, DVM, Roberta Wiederholt, DVM, Rob Lydon, DVM and Marty Allen DVM.

**PRE-VET CHECK:** Friday, June 27, 2008, 4:00 p.m. to 8:00 p.m. All horses must be pre-vetted and numbered before starting the ride. A pre-ride meeting will be held approximately at 8:00 p.m.

**STARTING TIMES:** 75 mile ride - 5:00 a.m. (18 hours elapsed time given for completion), 50 mile ride - 6:00 a.m. (12 hours elapsed time given for completion), 30 mile ride - 9:00 a.m. (7:15 hours elapsed time given for completion)

**AWARDS:** Completion awards will be given to all successful finishers on all three rides. There will also be awards for the Overall Winner, 1<sup>st</sup> in each weight division, 1<sup>st</sup> Junior, Best Condition and Top Ten for both the 75 and 50 mile rides. A Horse Excellence Award will be awarded among all horse completing the 30 mile ride. Please pick up your awards if you are not staying for the awards presentation, as they will not be mailed.

Desserts & Appetizers will be served following the 50 mile ride at approximately 6:00 p.m. on Saturday. Ride results and an awards presentation will be announced. 75 milers will be served as they finish and may pick up their award at that time.

**ENTRY FEES:** 75 mile ride - \$95.00 if postmarked by 6/22/08, \$110.00 thereafter  
50 mile ride - \$90.00 if postmarked by 6/22/08, \$105.00 thereafter  
30 mile ride - \$85.00 if postmarked by 6/22/08, \$100.00 thereafter

Juniors ride for ½ price. NASTR members who have paid their 2008 dues can deduct \$5.00 from their entry fee. All non-AERC members must pay an additional \$15.00. Cancellations by 6/26/08 will receive a full refund. After 6/26/08 all but \$15.00 will be refunded. No Shows will not receive a refund. A \$25.00 fee will be charged for any returned checks. Checks will not be cashed until after the ride.

## NASTR Triple Crown

The NASTR 75 Mile Ride is the 2<sup>nd</sup> ride of the NASTR Triple Crown. It is put on to help support the Nevada All-State Trail Riders, Inc. Virginia City 100 Mile Ride.

Embroidered jackets will be awarded to all horse and rider teams who finish all three rides (same horse and rider). Trophies will be awarded for individual horses and embroidered vests for riders to finish all three rides. Placing will be based on accumulative ride times.



### NASTR RIDE RULES (also see AERC/AHA rules and regulations)

1. The rides are open to all persons and any breed or type of equine. Senior riders are persons over 16 years of age by December 1st of the competition year.
2. A Junior is a rider under the age of 16 as of December 1st of the year of competition. All Junior riders must be accompanied by a Senior rider sponsor at all times, who is 21 years of age or older, and must finish within 1 minute of that sponsor. The sponsor must agree to remain with the Junior throughout the ride. If the sponsor is eliminated during the ride, the Junior may continue with another willing sponsor upon notification to ride officials. Notification shall be made before the Junior continues to ride. All Junior riders are required to wear helmets.
3. There shall be no unauthorized horses on the trail.
4. Horses must be at least 60 months of age for the 50 & 75 mile ride, 48 months for the 30 mile ride, as confirmed by the Ride Vet.
5. Horses must be shod or have some kind of hoof protection.
6. Each horse and rider must cross the finish line within 18 hours elapsed time on the 75 mile ride, 12 hours elapsed time on the 50 mile ride, and 7:15 hours elapsed time on the 30 mile LD ride, to qualify for any awards.
7. The same horse and rider must pass all control points and stay on the marked trail to qualify for any awards.
8. There will be no ties allowed.
9. Abusive behavior or harassment of ride personnel, veterinarians, riders, crews, or volunteers will not be tolerated, and may be grounds for disqualification or cause of future entry refusal.
10. Abuse of the horse and use of stimulants and/or pain killers are prohibited. All horses shall be subject to blood and/or urine tests.
11. Riders/horse owners are financially responsible for any emergency treatment provided.
12. Ride Veterinarians' opinions will be final on all matters concerning the horse.
13. Ride officials' decisions will be final.
14. Violation of any of these ride rules shall be grounds for disqualification of horse and rider from this ride.
